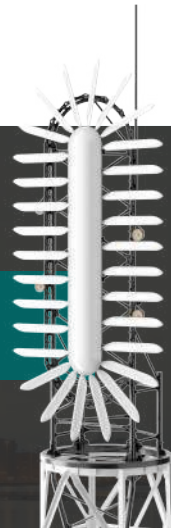

## **OVERVIEW**

Thank you for your interest in piloting the Sirocco Wind Panels. This pilot program is being offered to a limited number of customers. We hope you will find the Sirocco Panels to be useful in generating clean and stable energy for your business, save money and make your company green.

The pilot program has been initiated to determine what modifications need to be made to technology before mass production. Therefore, we will be relying heavily on your feedback, once you have used the Wind Panel.

# GENERAL

This Agreement sets out the terms and conditions to which the above Parties have agreed for the location testing, manufacturing, installation and servicing of the "SIROCCO Energy" wind generator.

## 1. CONTRACTOR DUTIES

The parties agree that the Contractor shall perform the following duties:

- 1.1.1. Conduct location testing and data analysis.
- 1.1.2. Produce and install for the Customer wind generator "Sirocco Energy", which characteristics are listed in the Annex 1.

## 2. QUALITY

- 2.1. The Contractor undertakes to deliver the wind generator in accordance with the specifications described in the Annex 1.
- 2.2. The Contractor is obliged to eliminate the defects of the Product, found during the warranty period, unless he proves that defects have arisen due to violation by the buyer of the rules of exploitation of the Product.
- 2.3. The warranty period is 36 months from the date of installation.

## 3. COST AND PAYMENTS

- 3.1. The cost of the wind generator described in the Annex 1.
- 3.2. The price includes location testing, Sirocco Wind Panel WP-5, inverter and tower, but doesn't including the costs of transportation, installation costs, consumables and payment of the necessary taxes.
- 3.3. Payment is made in three installments:
  - payment for the location testing. (Payment is made no later than 5 days after the contract signing).
  - deposit for the manufacture. (The Contractor starts production of the wind generator after receiving a deposit).
  - The third installment is paid after the installation of the wind generator.
- 3.4. Payment is made by cash or bank transfer.

## 4. CONSTRUCTION AND INSTALLATION TIME

4.1. Constructor performs the testing during 2-6 months. If the average wind speed at the location is less than 3.5 m/s, Constructor conducts a free testing of another customer's location. (But no more, than one free testing)

4.2. The Panel production time takes 60-90 working days.

4.3. The installation time is 30 working days from the date of delivery.

## 5. CONTRACT TERMINATION

5.1. This contract may be terminated at any time, by either party, upon 30 days written notice.

5.2. The paid funds are not returned in case of the termination of the contract

5.3. By signing below, both parties agree to be bound by the terms of this contract.
